DEPOSIT & FINAL PAYMENT

CANCELLATIONS

All cancellations must be made in writing to Beverly Hills Travel and are subject to Cunard's per person penalties as follows: From deposit to May 1, 2004, a \$100 penalty applies. Between May 2-25, 2004, a 10% penalty applies. Between May 26 and June 30, 2004, a 25% penalty applies. Between July 1-30, 2004, a 50% penalty applies. After July 30, 2004, or without written cancellation, a 100% penalty applies. In addition, all airlines have a non-refundable policy once tickets have been issued. One name change per cabin may be accepted at the discretion of Cunard, but a minimum \$75 fee will apply and the current cruise rate at the time of the change will prevail. Any last minute changes are subject to approval by Cunard. Additional fees may apply if travel documents must be reissued. **Trip cancellation insurance is highly recommended. Details regarding traveler's insurance will be forwarded to you upon receipt of application. Please note: If a roommate cancels the tour, the second passenger may travel, but the single occupancy rate applies.** The insurance policy will reimburse the cost of single occupancy should your roommate cancel for valid reasons as stated in the policy.

TRAVEL REQUIREMENTS

All passengers are required to carry a valid US passport with an expiration date no earlier than March 11, 2005. Non-US and Non-Canadian citizens (including those residing in North America) must carry a valid passport or resident alien identification. Please consult with the appropriate consulates to determine if any visas are needed.
